**AMENDMENT  
TO THE DECLARATION OF CONDOMINIUM OF  
SEAWATCH AT MARATHON. A CONDOMINIUM**

**(Additions shown by underlining; deletions by lined-through words)**

**Amendment to Article XXI, Section 21.01, to add Paragraph (r) to enact sound transmission limitations of floor coverings as follows:**

**21. OBLIGATIONS OF MEMBERS**

21.01 In addition to the other obligations and duties heretofore set forth in this Declaration, every unit owner shall:

- r. Not install any floor covering other than carpet in any portion of a unit other than foyers, kitchens and bathrooms unless the floor covering is installed over sound insulation materials. Furthermore, the floor and sound insulation materials, as installed, must be such that the resulting sound transmission shall be such that it achieves a minimum Sound Transmission Classification and Impact Isolation Classification of 52.
